Observed gas oven PC 1004108 is out of order. Repair gas oven.
CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.

Violation #56. Ventilation & lighting
Observed light fixtures in Walk-in cooler and Walk-in freezer unable to achieve required light intensities. The light intensity measure is 6 foot candles. Provide lights to Walk-in cooler and freezer.
CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
